MOTION TO RESCHEDULE COMPLIANCE HEARING

The Respondent, Glades Electric Cooperative, Inc., by and through undersigned counsel, and pursuant to Section 102.57 of the Board’s Rules and Regulations, hereby moves to reschedule the Compliance Hearing currently set for October 13, 2020 and in support thereof states:

1. This matter has been set for hearing on October 13, 2020.
2. Pursuant to 29 C.F.R. § 102.57, Respondent requests that the hearing be rescheduled due to an unavoidable and pre-scheduled conflict of Jeff Brewington—Respondent’s Chief Executive Officer, corporate representative, and one of the primary witnesses for the upcoming hearing.
3. More specifically, the National Rural Electric Cooperative Association’s (“NRECA”) “Regional Week” conference is scheduled to take place between October 12-16, 2020. The NRECA is a national service organization which represents more than 900-member electric cooperatives across the United States. Respondent is an NRECA member and Brewington is required to attend the conference both as a participant and also to assist Respondent’s Board Chairman throughout the week of the conference.

4. On account of Brewington's unavailability, Respondent moves to reschedule the October 13, 2020 Compliance Hearing to a later date.

5. Per Form NLRB-4338, undersigned counsel has conferred with representatives for the International Brotherhood of Electrical Workers, Local 1933 ("Local 1933"). Respondent is authorized to represent there is no objection to the relief requested herein and that all Parties are available for a rescheduled hearing between October 26-28, 2020. In the event the Region needs alternative dates in November, the Parties can provide them upon request.
