

REQUEST FOR REMAND

On September 30, 2020¹, the undersigned Regional Director of Region 25/Subregion 33 issued a Decision and Direction of Election directing that a mail ballot be conducted in the above-captioned matter beginning on October 13, 2020. On October 6, the Employer filed with the Board a Request for Review of my decision to order a mail ballot and an Emergency Motion to Stay the Election. On October 13, the Board granted the Employer's Emergency Motion and Request for Review.

In light of the arguments raised in the Employer's request for review, I request that the Board remand this matter for the purpose of allowing for reconsideration of my decision to conduct this election by mail.
