Dear Ms. Rothschild:

I write to request a six-week extension of time to file Counsel for Acting General Counsel's Exceptions and a Supporting Brief to the Administrative Law Judge's Decision ("ALJD") in these cases. Exceptions are currently due on February 5, 2021, and a six-week extension would move the due date to March 19.

I make this request for several reasons. There are significant legal and factual determinations that need to be addressed in the exceptions. It was a lengthy hearing, which took place over nine days between September 26, 2018 and November 20, 2018, with the ALJD issuing over two years later. The transcript is 1328 pages, with 66 exhibits. Additionally, I also must prepare for a hearing that is scheduled for February 23. Due to the complexities of litigating a hearing over Zoom, the preparation is more extensive than an in-person hearing.

Counsel for the Union joins in this request, but counsel for Respondent does not consent.
