**EXCEPTION TO THE DECISION OF THE
ADMINISTRATIVE LAW JUDGE**

The National Right to Work for Better Conditions Committee hereby takes exception to the refusal of the Administrative Law Judge to allow the Committee to intervene. At the hearing in this matter, the Committee sought to intervene and the ALJ rejected this request. It is not mentioned in the Decision we cannot refer to the page or line or punctuation.

Primarily the Committee was concerned about the involvement of the National Right to [censored] Committee or Legal Defense Foundation which interferes with the rights of employees to engage in concerted activity for better working conditions. The Committee opposes the campaign of that group to undermine the choice of employees to support their Union. This litigation raises important principles that the Committee wants to protect. The

Administrative Law Judge improperly refused to allow the Committee to intervene for those purposes. The Board should reverse the decision of the Administrative Law Judge and grant the motion to intervene. After granting the motion to intervene, it should allow the Committee to file a brief in this matter. The matter should be remanded to the ALJ so the Committee can prove the Right to [censored] Committee and or Legal Defense Foundation are criminal conspiracies and employer sponsored.
